**APPROVAL OF MINUTES**

**A. Woodward County LRTP.**

Herron discussed the TAZ maps needed to complete. Lickliter discussed the data needed for the body and that once she gets the TAZ data then the body will be ready for public review. All needed changes will be completed by Nov. 25. Schrahl made a motion

**B. Woodward County Public Review Period.**

It may take close to four years until completion. Also sometime in January the regional plan template will be sent out to policy board members. No action necessary.

The January technical committee meeting will be changed to the second Thursday instead of the first Thursday, and will be changed before sent to the Secretary of State.
