B. Approve FFY2021 PWP Draft for Public Review.

Eggers discussed the PWP draft with a 10-day public review period for May 4-15, 2020. NORTPO's PWP draft is due by July 1, and the approved PWP is due to ODOT by Sept. 1, 2020. With policy board meetings scheduled in July and September, Eggers suggested allowing the NORTPO Technical Committee, at their June 4, 2020 meeting, to review and approve submitting the PWP draft to ODOT on behalf of the policy board.

May moved to approve the FFY2021 PWP draft public review dates of May 4-15, 2020, and give authority to the NORTPO Technical Committee to approve and submit the FFY2021 PWP Draft to ODOT on behalf of the NORTPO Policy Board. C. Approve Regional Long Range Transportation Plan (LRTP) Official Name. Vision Statement: Northern Oklahoma Regional Transportation Planning Organization (NORTPO) will be a leader in regional transportation planning in northwest Oklahoma, providing opportunities to focus and address key regional transportation needs for safety, infrastructure, and future economic growth and development. E. Approve Regional LRTP Mission Statement.

The technical committee recommends, "The Northern Oklahoma Regional Transportation Planning Organization (NORTPO) serves as the regional forum to work collaboratively in the identification of transportation-related issues, and development of regional long-range transportation planning documents that improve the region's quality of life, safety, and promotes healthy communities and economic development. Focusing on key trends and needs over a 20-year planning period we will work together with stakeholders to provide rural connectivity to provide goods and services to and from our northwest region." as the regional LRTP mission statement. Tucker moved to approve the Regional LRTP Mission Statement as recommended by the NORTPO Technical Committee, seconded by Clonts. Motion Carried.
