

**Northern Oklahoma Regional Transportation Planning Organization
Technical Committee Meeting
July 11, 2019**

1. Call to Order/Introduction of Guests

Payton Herron called the NORTPO Technical Committee meeting to order at 1:06 PM.

2. Approve Previous Meeting Minutes from June 6, 2019
