

**Northern Oklahoma Regional Transportation Planning Organization****Technical Committee Meeting Minutes: Thursday, March 7<sup>th</sup>, 2024****1. Call to Order/Introduction of Guests (1:03)**

**2. Approve Previous Meeting Minutes from December 7<sup>th</sup>, 2023**

Eggers moved to approve the minutes from December 7<sup>th</sup>, 2023, seconded by Cory. Aye: Cory, Eggers, Ford, Rigdon and Sheets. Abstain: Schroder. Nay: none. Motion carried.

**3. Business (to meet, discuss, approve and/or consider recommending to the NORTPO Policy Board****A. Traffic Count Program**

Spencer discussed creating a flyer and website section for the traffic counts program and discussed locations for traffic counts in coordination with CED8. Schroder mentioned needing weeklong studies at 3 locations, Felt, Guymon, and Goodwell, and NORTPO agreed to complete those traffic studies. Spencer, and Rigdon also discussed wanting to use funds to possibly purchase pedestrian counters to assist with TAP applications in the future.

**B. OSU Collaboration**

Spencer discussed both the Rural Autonomous Vehicle Program (RAV) and Rural Research Initiative. For RAV NORTPO assisted with the application and offered some level of in-kind match with meetings if OSU is awarded.

**C. Grant Opportunities**

1. Safe Streets for All – Spencer discussed the grant program and shared the webinar information with the committee.
2. TAP – Spencer shared that TAP was open until April 31<sup>st</sup> for call for projects, and that May 31<sup>st</sup> was the project deadlines. Eggers shared about local stakeholders seeking information on TAP projects in the region. The known applications at this time were Woodward, Ponca City, and possibly Watonga.

**D. Story Map -**

Spencer showed the committee the progress on the regional plan story map and was provided feedback on the order of the maps. (No Action)

**E. Updates/Reports/Comments -**

Rigdon shared information regarding both ODOT's public outreach survey, and the planning department being joined with Mobility at ODOT.
