The major highways, connectors, and corridors were discussed. Major highways are as listed: US 81, US 412, and State HWY 74. Connectors are as listed: State Highways 15, 45, 152, and 164 plus Carrier Rd., Oakwood Rd., Keowee Rd., Breckenridge Rd., 114<sup>th</sup> St., Wood Rd., Flynn Rd., and 66<sup>th</sup> St. Corridors are as listed: US 81, US 412, State highways 74 and 132. Schroder moved to approve Garfield County's Major Highways, Connectors, and Corridors, seconded by Snethen. Motion carried. Aye: Snethen, Schroder. Nay: none. Licklitter and Eggers discussed the January dates for the next Stakeholder meeting.

Corridors are as listed: US 412, US 270, State HWY 34 & 50. Schroder moved to approve the Garfield County's Major Highways, Connectors, and Corridors, seconded by Snethen. Motion Carried. Aye: Snethen, Schroder. Nay: None. Licklitter discussed the LRTP's public review period and it was decided to discuss it further at the next Technical Committee Meeting.
