

**Northern Oklahoma Regional Transportation Planning Organization

**1. Call to Order/Introduction of Guests**

Tyler Schroder called the NORTPO Technical Committee meeting to order at 1:02 pm. Due to weather concerns Schroder moved to recess the meeting until 1:00 pm on Friday, Jan. 4, 2019. With no objections being heard the meeting was recessed until Friday, Jan. 4, 2019 at 1:00 pm. Meeting recessed at 1:03 pm.
