

**Northern Oklahoma Regional Transportation Planning Organization  
Technical Committee Meeting  
May 6, 2021**

The agenda for this meeting was posted in compliance with the Open Meeting Act. A complete packet of information is available for review in the NODA Office.

**1. Call to Order/Introduction of Guests**

Payton Herron called the NORTPO Technical Committee meeting to order at 1:09 PM. Present via Videoconferencing and NODA Conference Room: Vicki Eggers, Adam Gentis, Cecil Michael, Tiffany Plunkett, Jason Brinley, Kelly Parker and Tyler Schroder. Absent: Scott Armstrong, and Joe Schneider. A quorum was present. Staff Present: Payton Herron, Patti Hobbs, and Devon Westbrook. Guests: none.

**2. Approve Previous Meeting Minutes from April 2 and April 15, 2021**

Eggers moved to approve the minutes from the April 2 and April 15, 2021, NORTPO Technical Committee meetings, seconded by Michael. Motion carried. Aye: Gentis, Eggers, Schroder, Brinley, Plunkett, Parker, and Michael. Nay: none.

**3. Business (to meet, discuss, approve and/or consider recommending to the NORTPO Policy Board)**

**A. Introduction of Kelly Parker**

Herron introduced Parker to the committee, and Parker shared some of his relevant experience as mayor and his position on the Woods County Airport Commission.

**B. Collision Inventory Discussion**

Westbrook and Herron gave the committee an update on the collision data they are working on and their thoughts on representing the data in the plan. The committee decided they would present their findings for discussion at the June meeting.

**C. Website Items**

Westbrook showed that the new survey was added to the website and Eggers shared that the Noble and Grant County LRTPs would be added soon.

**D. Woods County MOU**

There was discussion about the Woods County MOU and how to go about contacting the County Commissioners to begin the process of authoring a Woods County LRTP.

**E. Re-order of LRTP Goals**

Westbrook presented results from the goals survey and asked if the committee thought there should be a restructuring in the order the goals are presented in the plan based on how the respondents answered, "What goal is most important to you?" Since 76% of respondents resided in Major County the committee agreed that

the results may not be representative of the region at large so a decision should not be made at this time, but that a more specific question about this topic should be included on a future public survey.

**4. Updates/Reports/Comments**

Herron brought up Sonny Biggoose from Ponca Tribe and asked if there were any updates on authoring a plan for the tribe, but Michael said he has not responded to him yet. Eggers shared that she had a contact from the Cheyenne-Arapaho tribe that she will be contacting soon to get the tribe more involved in NORTPO's transportation planning process.

Michael moved to adjourn, seconded by Schroder. Motion carried. Aye: Gentis, Eggers, Schroder, Brinley, Plunkett, Parker, and Michael. Nay: none. Meeting adjourned at 1:40 PM.
