APPROVAL OF MINUTES

May moved to approve the minutes from the September 23, 2021 meeting, seconded by Hess. Motion carried.

BUSINESS (To meet, discuss & possibly take action on the following items):

A. FFY 2022 Joint Certification

Westbrook stated the joint certification outlines work completed in the previous year and work to be completed in FFY 2022 per NORTPO's agreement with ODOT. He also stated no major changes from last year's agreement, only the work activities drawn from staff monthly reports. A motion for approval was requested for submission to ODOT. B. Approve FFY 2022 NORTPO Meeting Schedule
